Important **figures and tables** (1 to 2) and **recent references** (2 to 5) can be added after keywords as presented in this template. Please remove any sample tables or figures if you are not adding your own when submitting the abstract. Please ensure that all abstract content fits **strictly within one A4-sized page** with standard margins, following the guidelines provided in this template. Use three to five keywords in alphabetical order separated with semicolons. Keywords should ideally be phrases of 2-4 words. **Abstracts not following these guidelines will be returned.** It is considered that, author has read and followed all necessary guidelines before abstract submission. Also, it is assumed that all authors are aware about the necessary information about the author's ethics, plagiarism, registration, presentation and publication before the submission of the abstract. 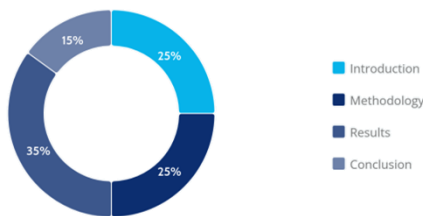


Fig. 1. Parts of an abstract (TNR, 9) (Replace or remove figure as applicable)
